Jonathan Willbours & James Tucker to take a suitable
opportunity with him in order for his help and
restoration; and report at next mo. m.

It appearing & necessary to appoint a Comtee
to have the care of the burying ground and who of these
such as are not members shall be enticed there in, we
therefore appoint Wm Gifford Joseph Tucker John Tucker
Joseph Gifford Junr. Thos. Mott Lutham Wood & Jos. Lottis
and Humphrey Russell to attend to that service
